

Part 360 Transition Requirements for Beneficial Use Determinations (BUDs)

 Pre-determined BUDs from before 11/4/17 – Expired May 3, 2018

 All case-specific BUDs in effect prior to November 4, 2017 that do not contain an expiration date have now expired - unless a renewal request has been submitted to DEC

360.12(a) - Applicability

360.12(a) – Applicability

- 360.12 Beneficial Use does not apply to:
 - Materials being sent to Part 361 facilities
 - Waste used in a manner that constitutes disposal
- The Department reserves the right to require a permit for land placement to protect public health or the environment
- Default storage time limit of 365 days



360.12(b) Unacceptable Uses

Flowable fill in mined land reclamation

Encasement of waste tires in concrete

Waste tires as fences or screening



360.12 - Pre-Determined Beneficial Uses

- Annual reporting for quantities greater than 10,000 tons
- Grouped by when the material ceases to be solid waste four groups:
 - (1) When used as...
 - (2) When received at location of use as...
 - (3) When meeting specifications/ requirements for use as...
 - (4) When leaving a Material Handling and Recovery Facility (Part 361)



360.12 – Pre-Determined Beneficial Uses: Examples

- Street sweepings, car wash grit and catch-basin cleanout material as aggregate or fill
- Bread and grain products, including spent brewery grains, as animal feed
- Tire and glass aggregates (with specifications)
- Wood debris as mulch



360.12 – Pre-Determined Beneficial Uses: Examples (continued)

- Sandy navigational dredged material as commercial aggregate
- Concrete, brick and rock as aggregate (RCA)
- Asphalt pavement and millings in pavement and road construction (RAP)
- Fill Material generated outside of NYC with no history/ suspect contamination (no sampling required; unrestricted use)
- Fill Material used in accordance with 360.13



360.12(d) – Case-Specific Beneficial Use Determinations: General

- Case-by-case review for any byproduct or waste material
- Review criteria ("essential nature is use not disposal", "managed as a commodity", "will not adversely affect health and the environment", etc.)
- Lower of 6 NYCRR 375-6.8(b) Protection of Public Health-Residential Land Use and Protection of Groundwater Soil Cleanup Objectives for soil-like materials placed on the land
- All case-specific BUDs expire no more than 5 years from effective date
- Annual reporting for all case-specific BUDs
- Right to hearing for revocation



360.12(e) – Case-Specific Beneficial Use Determinations: Navigational Dredged Material (NDM)

- Does not apply to NDM managed under a dredging permit (federal or state) – 360.2(a)(3)(xi) exclusion
- Modified petition contents for NDM
- Minimum sampling requirements for NDM sampling performed with approval of the Department's Division of Water or the US Army Corps of Engineers can be substituted



360.12(f) – Case-Specific Beneficial Use Determinations: Gas Storage Brine or Production Brine

- Applies to use of brine for road treatment (dust control and stabilization of unpaved roads; de-icing of paved roads)
- Specialized petition contents relevant to brine
- *Minimum* concentrations of beneficial salts
- *Maximum* concentrations of pollutants (e.g., benzene)
- Specifies practices to ensure minimum runoff into surface water bodies
- Annual reporting and brine analysis required
- Road spreading of brine from the Marcellus formation prohibited
- Road spreading of drilling fluids and flowback water prohibited

The Challenge of Fill Material

360.13 – Special Requirements for Pre-Determined Beneficial Use of Fill Material

Subdivisions:

- Applicability
- Waste cessation
- Exemption for on-site reuse of fill material
- Testing requirements for fill material
- Sampling and analysis requirements for fill material
- Acceptable fill material uses
- Other fill material use criteria



360.13(a) - Applicability

Fill Material means soil and similar material excavated for the purpose of construction or maintenance...(360.2(b)(107))

Section 360.13 allows for the **self-assessment** of fill materials for appropriate use within 360.13 criteria.



360.13(a) - Applicability

Section 360.13 <u>DOES NOT</u> apply to:

- Fill material sent to C&D Debris Handling and Recovery Facilities (CDDHRFs)
- Fill material generated outside of NYC with no evidence of historical impacts such as reported spill events, or visual or other indication of chemical or physical contamination



360.13(a) - Applicability (continued)

Section 360.13 DOES NOT:

- Require all excavated soil or fill to be sampled
- Require sampling of material sent to CDDHRFs
- Prevent anyone from petitioning for a case-specific BUD pursuant to 360.12(d) for fill material



360.13(c) – Exemption for On-Site Reuse of Fill Material

- Materials excavated at a site can be used anywhere on the site in areas of similar physical characteristics
- If contaminated material will be used on a site with public access, minimum of 1 foot of clean soil cover must be placed
- Not applicable to Part 375 program sites



360.13(d) and (e) – Testing requirements for Fill Material

- Where and when required
- Parameters required and contingent
- Frequency
- Visual estimate of physical contamination
- By Qualified Environmental Professional (QEP)



360.13(f) – Acceptable Fill Material Uses: Tested Fill Material

General Fill

Restricted-Use Fill

Limited-Use Fill

360.13(f) – Acceptable Fill Material Uses

Fill Material Type	% Inert, Non-Soil Material	Chemical Concentration Criteria	Allowable Use
General Fill	Zero	Lower of Residential & Groundwater SCOs in Part 375	Anywhere except undeveloped or agricultural land
Restricted- Use Fill	40	Same as General, but up to 3 ppm Ba(P) equivalent	On any land with more heavily contaminated material or in transportation corridors
Limited-Use Fill	100	Same but up to Commercial SCO metals; Ba(P) equiv.	Under foundations or pavements, above the water table




360.13(f) – Acceptable Fill Material Uses

- Inert, non-putrescible material can include ash or C&D debris, but excludes plastic, gypsum wallboard, wood, paper, or other material that may readily degrade or produce odors
- Due to the Long Island Landfill Law, in Nassau and Suffolk Counties Restricted-Use Fill criteria must meet stricter criteria and Limited-Use Fill is prohibited
- Notification to DEC at least 5 days in advance of movement for fill material generated in, transferred in, or imported to NYC in quantities greater than 10 CY

Where Did Fuel Approvals Go?

362-1.2 – Combustion Facilities and Thermal Treatment Facilities: Exemption

 Facility that combusts alternative fuel authorized under 6 NYCRR Part 212 or 227

362-1.3 or 1.4 – Combustion Facilities and Thermal Treatment Facilities: Registration or Permit

Facility that stores wastes for fuel use



Where Did In-Landfill Approvals Go?

363-6.21 – Landfills – Operating Requirements

- Alternate daily cover does NOT require a BUD
 - Performance-based criteria for ADC
 - Limitation on sulfates
- Construction components inside the landfill environmental containment area do NOT require a BUD
 - Equivalent design



DEC Enforcement Discretion Letter

March 1, 2018



March 1, 2018 Enforcement Discretion Letter

Until May 3, 2019 or regulation is amended:

- Source-separated concrete, brick and rock are free from regulation as long as they are under control of the entity who generated them, and they are destined for processing and beneficial use under 360.12(c)(3)(viii)
- Asphalt pavement and millings under control of the generator are free from regulation if destined for processing and use under 360.12(c)(3)(ix) or (x).
- "RUCARBS" for mine reclamation can be used but only pursuant to a Mineral Resources Permit



Don't mix "RUCARBS" – Source-Separate Them!



March 1, 2018 Enforcement Discretion Letter

Until May 3, 2019 or regulation is amended:

- Sampling of residue and fill material leaving CDDHRFs for reuse will not be enforced for CDDHRFs with permits that are renewed after November 4, 2017, but before May 3, 2019.
- Waste Tires used to secure tarpaulins on farms do not need to meet requirements under 360.12(c)(2)(iv).
